



# Materials Management Declaration

---

Troy Innovative Instruments is committed to managing the use of chemical substances in accordance with governmental regulations, industry standards, and customer-specific requirements in order to protect the environment. As such, we make the following declarations with regards to the products we manufacture.

## REACH Compliance Declaration

Under the definition of the REACH regulations EC1907/2006, Troy Innovative Instruments is a producer of “articles”. REACH requires article suppliers to inform recipients if an article contains a Substance of Very High Concern (SVHC) in excess of 0.1% by weight. The EU announced on June 27th, 2018 an updated list of the candidate 191 SVHC chemicals. The list can be found at:

Based on the material content certifications provided by Troy Innovative suppliers, none of these substances are present in the materials we use in our products. Therefore, Troy Innovative products do not contain any of these SVHC in excess of 0.1% by weight. Troy Innovative will continue to comply with REACH requirements and notify customers of any change in article content.

## Statement regarding RoHS 3, or Directive 2015/863, Compliance

Troy Innovative Instruments products comply with RoHS 3, or Directive 2015/863, which adds 4 phthalates to RoHS 2 Directive 2011/65/EU. Specifically, Troy Innovative products do not exceed the allowable limits for the following restricted substances:

- Lead - (0.1 % by mass or 1000 PPM)
- Mercury - (0.1 % by mass or 1000 PPM)
- Cadmium - (0.01 % by mass or 100 PPM)
- Hexavalent chromium - (0.1 % by mass or 1000 PPM)
- Polybrominated biphenyls (PBB) - (0.1 % by mass or 1000 PPM)
- Polybrominated diphenyl ethers (PBDE) - (0.1 % by mass or 1000 PPM)
- Bis(2-ethylhexyl) phthalate (DEHP) - (0.1 % by mass or 1000 PPM)
- Butyl benzyl phthalate (BBP) - (0.1 % by mass or 1000 PPM)
- Dibutyl phthalate (DBP) - (0.1 % by mass or 1000 PPM)
- Diisobutyl phthalate (DIBP) - (0.1 % by mass or 1000 PPM)

## California Proposition 65 Declaration

Products manufactured by Troy Innovative do not contain chemicals which are listed on California’s Safe Drinking Water & Toxic Enforcement Act of 1986. This Act, commonly known as Proposition 65 (Prop 65), establishes a list of chemicals which the state of California’s risk assessment process has determined to present a risk of cancer, birth defects or other reproductive harm.
